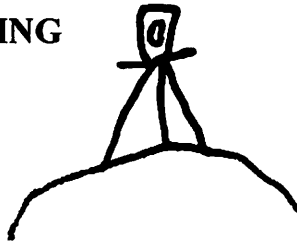

COMMENCING at a 5/8" rebar set per said survey record, at the Northwest Corner of said Lot 77, also being the Southeasterly right of way intersect of Water Street and McArthur Street, and being the **TRUE PLACE OF BEGINNING** of the herein described parcel;

1. Thence, Southeasterly with the North line of said Lot 77 and the South right of way line of Water Street, **South 78° 00' 00" East**, a distance of **75.00 feet** to a 5/8" rebar set per said survey record,

2. Thence, leaving said line, Southwesterly through said Lot 77, **South 14° 23' 10" West**, a distance of **60.05 feet** to a point on the line common to said Lot 77 and Lot 78 of same Plat per said survey record;

3. Thence, Northwesterly, with said line between said Lots 77 and 78, **North 78° 00' 00" West**, to a of **72.50 feet** to a Southwesterly corner of said Lot 77 and the Northwesterly corner of said Lot 78, and being on the Easterly right of way of McArthur Street per said survey record;

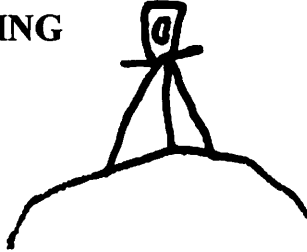
