3.) thence N88°39'40"E, 1094.63' along the south line of a 16.5' alley to a ½" pipe found;

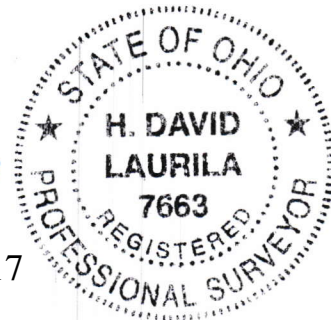
4.) thence S01°27'58"E, 203.54' to the **TRUE POINT OF BEGINNING**.
