

Boundary description of 2.746 acre parcel

Situated in the Village of Dalton, T-16N; R-11W, Southeast and Southwest Quarter of Section 4, and Northeast Quarter of Section 9, County of Wayne, and State of Ohio:

Known as being a part of lands conveyed to Leonard R. & Sharon K. Wenger in O.R. 842; Page 19 of Wayne County Official Records and further bounded and described as follows:

Commencing at the 3/4" solid pin marking of the Southwest corner of the Southeast Quarter of Section 4;

Thence S 89° 34' 28" W, 107.59 feet along the southerly line of the Southwest Quarter of Section 4 to a 1-1/4" pipe at the southeast corner of a 2.11 acre parcel of land conveyed to Leonard R. & Sharon K. Wenger as recorded in O.R. 842; Page 19 of Wayne County Official Records;

Thence N 00° 22' 12" E, 176.31 feet along the east line of said Wenger lands to a 5/8" rebar with I.D. cap marked "S.J.L., INC" set and the principal place of beginning of the parcel herein described:

## THENCE WITH THE FOLLOWING SIX (6) COURSES:

- 1. **N 00° 22' 12" E, 70.23** feet to a 3/4" rebar found on a southerly line of land conveyed to Pac Land Holdings, LLC as recorded in O.R. 743; Page 771 of Wayne County Official Records;
- 2. **S 82° 08' 52" E, 107.88** feet along a southerly line of said Pac Land lands to an 5/8" rebar found on the west line of aforesaid Southeast Quarter of Section 4;

- 3. **S 81° 56' 18"** E, **631.15** feet along an easterly prolongation of in Old Lincoln Way (C.R. 30A) and along Village of Dalton Corp. Line to a point at a northeast corner thereof ~ witnessed by a 5/8" rebar with I.D. cap marked "S.J.L., INC" set S 01° 11' 13"E, 30.00 feet;
- 4. **S 01° 11' 13" E, 298.72** feet along said Corp. Line to a 5/8" rebar with I.D. cap marked "S.J.L., INC" set and on the centerline of U.S. Route 30;
- 5. **N 58° 13' 31" W, 27.21** feet along the centerline of U.S. Route 30 to a Disc in concrete found at a point of curvature;
- 6. northwesterly, along the centerline of U.S. Route 30, 784.98 feet along the arc of a curve deflecting to the left, said curve having a radius of 2864.79 feet, a central angle of 15° 41' 59" and a chord which bears N 66° 04' 31" W, 782.53 feet to the principal place of the beginning and containing within said bounds 2.746 acres of land, more or less, and subject to all legal highways and easements of record.
