

BOUNDARY DESCRIPTION
83.086 Acres

Situated in the State of Ohio, County of Wayne, **Township of East Union** in the **southeast quarter of Section 25, T-16N, R-12W.**

Being part of the land described in a deed to **Dan U. and Betty Miller** recorded in official record volume 369, page 1958 of the Wayne County records.

Described as follows:

Beginning at a stone monument found on the line between East Union Township and Sugar Creek Township marking the northeast corner of the southeast quarter of Section 25.

Thence with the following **ELEVEN** courses:

- 1) **S 4° 00' 07" W 1112.18 feet**, along the township line and the east line of the quarter section, to a stone monument found.
- 2) **S 4° 03' 26" W 1124.11 feet**, along the township line and the east line of the quarter section, to a 1-1/2 inch diameter steel pipe found at the northeast corner of Melvin P. and Marie Weaver as described in official record volume 50, page 776.
- 3) **N 87° 08' 00" W 210.75 feet**, along the north line of Weaver, to a magnail set in concrete.
- 4) **S 4° 01' 54" W 248.96 feet**, along the west line of Weaver, to a capped pin found at the northeast corner of Melvin P. and Marie E. Weaver as described in official record volume 897, page 3646.
- 5) **N 87° 08' 00" W 503.35 feet**, along the north line of Weaver, to a 5/8 inch diameter steel pin found.
- 6) **S 5° 15' 54" W 163.12 feet**, along the west line of Weaver, to a railroad spike found in Emerson Road (County Road 79) on the south line of the quarter section – witnessed by a capped reference pin set **N 5° 15' 54" E 36.73 feet**.
- 7) **N 87° 08' 00" W 1100.96 feet**, in Emerson Road and along the south line of the quarter section, to a point – witnessed by a capped reference pin found **N 3° 36' 25" E 25.00 feet**.
- 8) **N 3° 36' 25" E 437.96 feet**, in part along an easterly line of Lot 14 of the Roman Yoder Allotment recorded in plat volume 29, page 178, to a capped pin set.

- 9) **S 86° 59' 48" E 480.29 feet**, along the south line of Wyman D. and Naomi H. Miller as described in official record volume 642, page 868, to a capped pin found at the southeast corner thereof.
- 10) **N 3° 34' 15" E 2221.29 feet**, along the east line of Miller and the extension thereof, to a point in an oak tree on the north line of the quarter section – witnessed by capped reference pins set S 3° 34' 15" W 5.12 feet and S 89° 42' 16" E 10.00 feet.
- 11) **S 89° 42' 16" E 1359.13 feet**, along the north line of the quarter section, to the **Point of Beginning**.

This parcel contains 83.086 acres and is subject to the sewer easement described in official record volume 369, page 1958.
