

BOUNDARY DESCRIPTION
17.972 Acres

Situated in the State of Ohio, County of Wayne, **Township of Wooster** in the **northwest quarter of Section 12, T-15N, R-13W.**

Being part of the land described in a deed to **Michael E. Culler** recorded in deed volume 691, page 297 of the Wayne County records.

Described as follows:

Commencing at a 1-1/2 inch diameter crimped steel pipe found marking the northwest corner of Section 12.

Thence S 02° 32' 46" W 429.21 feet, along the west line of the quarter section, to the **Point of Beginning** for the parcel herein described – witnessed by a capped reference pin set S 58° 11' 30" E 10.15 feet.

Thence with the following EIGHTEEN courses:

- 1) **N 40° 44' 10" E 100.18 feet**, along the easterly line of the Wayne County Commissioners as described in official record volume 437, page 705, to a capped pin set on the southerly line of State of Ohio (U.S. 30, a limited access highway) as described in official record volume 443, page 1927.

The following FIVE courses (courses 2 through 6) follow the southerly line of the State of Ohio and the southerly line of U.S. 30.

- 2) **S 79° 36' 48" E 49.74 feet** to a 3/4 inch diameter steel pin found at a point of curvature.
- 3) **Southeasterly**, along the arc of a curve to the left, a distance of 652.17 feet to a 3/4 inch diameter steel pin found.

The aforementioned curve has the following properties:

Central Angle = 04°48'34"

Radius = 7769.44 feet

Chord Bearing = S 82° 01' 05" E

Chord Distance = 651.98 feet

- 4) **S 82° 21' 36" E 203.77 feet** to an O.D.O.T. highway right of way monument found.
- 5) **N 89° 12' 08" E 305.74 feet** to a capped pin set.
- 6) **S 88° 44' 51" E 26.59 feet** to an O.D.O.T. highway right of way monument found.
- 7) **S 35° 45' 57" W 805.90 feet**, along the westerly line of GSO Enterprises, LLC as described in official record volume 879, page 2062, to a 5/8 inch diameter steel pin found on the north right of way line of East Lincoln Way (County Road 30A).
- 8) **S 00° 33' 53" W 65.00 feet** to a point on the centerline of East Lincoln Way.

- 9) **N 89° 26' 07" W 64.43 feet**, along the centerline of East Lincoln Way, to a point of curvature - witnessed by a capped reference pin set N 00° 33' 53" E 65.00 feet.
- 10) **Northwesterly**, along the arc of a curve to the right and the centerline of East Lincoln Way, a distance of 516.66 feet to a point of tangency – witnessed by a capped reference pin set N 01° 42' 20" W 42.00 feet.

The aforementioned curve has the following properties:

Central Angle = 01° 08' 27"

Radius = 25948.08 feet

Chord Bearing = N 88° 51' 54" W

Chord Distance = 516.65 feet

- 11) **N 88° 17' 40" W 274.91 feet**, along the centerline of East Lincoln Way, to a point in the intersection of Geyers Chapel Road (Township Road 68) on the west line of the quarter section – witnessed by a capped reference pin found N 37° 24' 25" E 50.36 feet.
- 12) **N 02° 32' 46" E 402.47 feet**, along the west line of the quarter section and in Geyers Chapel Road, to the southwesterly corner of Wayne County Commissioners as described in official record volume 443, page 1932.

The following FIVE courses (courses 13 through 17) follow the lines of the "Commissioners"

- 13) **S 87° 27' 14" E 30.00 feet** to a 3/4 inch diameter steel pin found.
- 14) **N 02° 32' 46" E 85.00 feet** an O.D.O.T. highway right of way monument found.
- 15) **N 33° 24' 43" E 41.68 feet** to a 3/4 inch diameter steel pin found.
- 16) **Northeasterly**, along the arc of a curve concave to the west, a distance of 262.05 feet to a 3/4 inch diameter steel pin found.

The aforementioned curve has the following properties:

Central Angle = 176° 38' 28"

Radius = 85.00 feet

Chord Bearing = N 02° 02' 40" E

Chord Distance = 169.93 feet

- 17) **N 87° 29' 27" W 49.90 feet** to a capped pin set on the west line of the quarter section.
- 18) **N 02° 32' 46" E 54.48 feet**, along the west line of the quarter section, to the **Point of Beginning**.

This parcel contains 17.972 acres.
