Description 5.000 acre parcel

Situated in the Township of Canaan (T-17 N, R-13 W), southwest quarter of Section 17, County of Wayne and State of Ohio.

Described as follows:

Commencing at a 5/8 inch rebar found in Parmenter Road aka T.R. 347 marking the northwest corner of the southwest quarter of Section 17, thence S 01 degrees 42' 37" E 497.05 feet along the section line and along Parmenter Road aka T.R. 347 to a point, thence N 88 degrees 08' 30" E 889.20 feet along Charles D. Boos' (O.R. 951 page 2991) south line to an iron pin set the TRUE POINT OF BEGINNING.

thence with the following FOUR (4) COURSES:

- 1) N 88 degrees 08' 30" E 580.80 feet along said Boos' south line to an iron pin set;
- 2) S 01 degrees 51' 30" E 375.00 feet through the lands of Temabojuka LLC (O.R. 956 page 1052) to an iron pin set;
- 3) S 88 degrees 08' 30" W 580.80 feet through the lands of said Temabojuka LLC to an iron pin set;
- 4) N 01 degrees 51' 30" W 375.00 feet through the lands of said Temabojuka LLC to the TRUE POINT OF BEGINNING.

This parcel contains 5.000 acres, but subject to all highways and easements of record.

This parcel is subject to and has access by a 30 foot easement for the purpose of ingress, egress, and general utilities, further described as follows:
