

BOUNDARY DESCRIPTION
52.158 Acres

Situated in the State of Ohio, County of Wayne, **Township of Green** in the **northeast and southeast quarters of Section 33, T-17N, R-12W.**

Being all of the land described in a deed to **Debra A. Marthey and Diane M. Fries, Co-Trustees of the Geraldine M. Marthey Revocable Trust U/A/D May 13, 2019**, recorded in official record volume 896, page 1211 of the Wayne County records.

Described as follows:

Beginning at a granite stone monument found marking the center of Section 33.

Thence with the following EIGHT courses:

- 1) **N 00° 18' 25" E 264.00 feet**, along the west line of the northeast quarter, to a 5/8 inch diameter steel pin found at the southwest corner of Douglas J. Shoup and Goodness of God LLC as described in deed volume 651, page 280 and official record volume 962, page 4653 respectively.
- 2) **S 89° 31' 12" E 1430.29 feet**, along the south line of Shoup et al., to a 5/8 inch diameter steel pin found on the west line of a 5.03 acre parcel described in a deed to Dawna Beery Kohr recorded in official record volume 744, page 571.
- 3) **S 04° 50' 48" E 264.17 feet**, along the west line of Kohr, to a point on the south line of the quarter section – witnessed by a one inch diameter steel pipe found S 04° 50' 48" E 0.79 feet.
- 4) **S 89° 33' 30" E 530.29 feet**, along the south line of the quarter section, to a 5/8 inch diameter steel pin found in Millborne Road (Township Road 142) – witnessed by a one inch diameter steel pin that bears N 87° 32' 01" W 30.15 feet.
- 5) **S 12° 20' 41" E 782.00 feet**, into the southeast quarter along the west line of a 0.389 acre parcel described in a deed to Michelle Baab, Trustee recorded in official record volume 941, page 5523 and the extension thereof, to a railroad spike found in Millborne Road.
- 6) **S 11° 44' 17" E 143.34 feet**, in Millborne Road, to the northeast corner of Trevor C. Marthey as described in official record volume 435, page 2599 and page 2602 – witnessed by a capped reference pin set N 89° 45' 38" W 26.81 feet.
- 7) **N 89° 45' 38" W 2187.42 feet**, along the north line of Marthey, to a capped pin set on the west line of the quarter section.

8) N 00° 25' 41" E 910.45 feet, along the west line of the quarter section, to the **Point of Beginning**.

This parcel contains 52.158 acres; of which 8.724 acres lie in the northeast quarter and 43.434 acres lie in the southeast quarter of Section 33.
