

BOUNDARY DESCRIPTION

2.000 Acres

Situated in the State of Ohio, County of Wayne, **Township of East Union** in the **northeast quarter of Section 24, T-16N, R-12W.**

Being part of the land described in a deed to **Andy E. and Mattie Troyer** recorded in deed volume 721, page 86 of the Wayne County records.

Described as follows:

Commencing at a 1-1/2 inch square bolt found in Kansas (Township Road 179) marking the southwest corner of the northeast quarter of Section 24.

Thence N 05° 00' 09" E 60.07 feet, along the west line of the quarter section and in Kansas Road, to the **Point of Beginning** for the parcel herein described – witnessed by a 5/8 inch diameter steel reference pin found S 87° 45' 44" E 30.03 feet.

Thence with the following FOUR courses:

- 1) **N 05° 00' 09" E 362.14 feet**, along the west line of the quarter section and in Kansas Road, to a point – witnessed by a capped reference pin set S 83° 46' 42" E 81.96 feet.
- 2) **S 83° 46' 42" E 246.45 feet** to a capped pin set.
- 3) **S 05° 00' 09" W 345.00 feet** to a capped pin set.
- 4) **N 87° 45' 44" W 246.69 feet** to the **Point of Beginning.**
