Masters in Volume 703; Page 60 of Wayne County Deed Records and being the principal place of beginning of the parcel herein described ~ witnessed by a 5/8" rebar with I.D. cap marked "SJL, INC" set S 89° 34' 39" W, 30.00 feet:

1. continuing S 00° 04' 03" W, 494.34 feet along the east line of said Southwest Quarter to a 5/8" rebar with I.D. cap marked "SJL, INC" set at the northeast corner of lands conveyed to Robert E. Graber aka Robert Graber in Volume 892; Page 676 of said Official Records;
2. S 89° 24' 42" W, 1276.72 feet along the north line of said Graber lands to 3/4" solid pin found at the southeast corner of a parcel of lands conveyed to E. Lamar & Sandra J. Martin in Volume 195; Page 870 and in Mt. Eaton Road (S.R. 94) ~ Witnessed by a capped pin with I.D. cap marked "PURDY" found N 89° 24' 42" E, 40.00 feet;
3. N 10° 20' 05" W, 505.56 feet along an east line of said Martin lands and in said Mt. Eaton Rd. to the southwest corner of aforesaid Masters lands ~ witnessed by a 5/8" rebar with I.D. cap marked "SJL, INC" set N 89° 34' 39" E, 22.00 feet;
