Situated in the Township of Wooster, T-15N; R-13W, Northeast Quarter of Section 17, County of Wayne, and State of Ohio:

Known as being the lands conveyed to Justin Torrence by Official Record Volume 950; Page 2563 of Wayne County Records and further bounded and described as follows:

Commencing at a 5/8 inch rebar found in the intersection of Heyl Road, (County Road 139), and Old Columbus Road, (County Road 3A), and being the northeast corner of the Northeast Quarter of Section 17, Wooster Township;

Thence, N 89° 24' 39" W, 496.42 feet along the Section Line and with Heyl Road to a point witnessed by a 3/4 inch iron pipe found S 26° 53' 54" E, 34.87 feet and the principal place of beginning of the parcel herein described:

**THENCE WITH THE FOLLOWING FIVE (5) COURSES:**

1. **S 26° 53' 54" E, 151.34 feet** along the Grantor's easterly line and the westerly line of the lands conveyed to Robert R. & Sara N. Barstow by Official Record Volume 621, Page 1085 of Wayne County Records;
2. **S 75° 13' 16" W, 70.35 feet** along the Grantor's southerly line and the northerly line of the lands conveyed to Jason K. & Hallie L. Morris by Official Record Volume 633, P-1470 of Wayne County Records to a 3/4 iron pipe found;
3. **S 54° 35' 56" W, 56.00 feet** along the Grantor's southerly line and the northerly line of said Morris lands and the lands conveyed to James P. & Jan M. Hughes by Official Record Volume 258, Page 223 of Wayne County Records 3/4 rebar found;
4. **N 15° 41' 04" W, 193.56 feet** along the Grantor's westerly line and the easterly line of the lands conveyed to The Trustees of Wooster Township by Official Record Volume 459, Page 2422 of Wayne County Records to a 3/4 inch iron pipe found;



5. **S 89° 24' 39" E, 97.53 feet** along the section line, the Grantor's northerly line and with Heyl Road to the principle place of beginning and containing within said bounds **0.408** acres of land, more or less, and subject to all legal highways and easements of record.
