

BOUNDARY DESCRIPTION
62.634 Acres

Situated in the State of Ohio, County of Wayne, **Township of East Union** in the **southeast quarter of Section 11** and the **southwest quarter of Section 12, T-16N, R-12W.**

Being part of the land described in a deed to **Jonathan N. Troyer and Jodi R. Troyer** recorded in official record volume 959, page 1067 of the Wayne County records.

Described as follows:

Beginning at a 1-1/2 inch diameter steel pin found marking the southeast corner of Section 11.

Thence with the following FIFTEEN courses:

- 1) **S 88° 39' 20" W 481.54 feet**, along the south line of the quarter section, to a one inch diameter steel pipe found in Carr Road (County Road 94-A) – witnessed by a capped reference pin set N 88° 39' 20" E 28.75 feet.
- 2) **N 20° 51' 20" E 132.40 feet**, in Carr Road, along the easterly line of Elrox Company LLC as described in official record volume 921, page 5361 and the extension thereof, to a railroad spike found.
- 3) **N 20° 36' 26" E 247.94 feet**, in Carr Road, along the easterly line of Anna E. Troyer as described in official record volume 919, page 4196, official record volume 961, page 1145 and the extension thereof, to a railroad spike found.
- 4) **N 22° 18' 21" E 860.82 feet**, in Carr Road, along the easterly line of Richard A. and Jackie S. Smith as described in official record volume 441, page 871 and the extension thereof, to a point – witnessed by a capped reference pin set N 86° 15' 09" E 31.09 feet.
- 5) **N 86° 15' 09" E 588.26 feet**, passing into the southwest quarter of Section 12 at a distance of 7.76 feet, to a capped pin set.
- 6) **N 00° 37' 46" W 252.06 feet** to a capped pin set.
- 7) **S 87° 21' 50" W 580.00 feet** to a point on the west line of the quarter section and in Carr Road – witnessed by a capped reference pin set N 87° 21' 50" E 23.51 feet.
- 8) **N 00° 37' 46" W 104.63 feet**, along the west line of the quarter section and in Carr Road, to the southwest corner of Paul D. and Laura S. Troyer as described in official record volume 645, page 561 – witnessed by a capped reference pin found N 88° 27' 12" E 13.61 feet.

- 9) N 88° 27' 12" E 475.38 feet, along a southerly line of Troyer, to a capped pin found.
- 10) N 02° 53' 53" W 365.08 feet, along an easterly line of Troyer, to a capped pin set.
- 11) N 20° 50' 22" E 139.01 feet, along an easterly line of Troyer, to a capped pin set.
- 12) N 87° 01' 11" E 280.33 feet, along a southerly line of Troyer, to a stone monument found at a westerly corner of an 88.22 acre tract described in a deed to DRRRVN EZ LLC recorded in official record volume 779, page 2466.
- 13) N 85° 46' 36" E 636.04 feet, along a southerly line of the 88.22 acre tract, to a capped pin marked "Rudolph 6449" found.
- 14) S 00° 12' 37" W 2019.64 feet, along a westerly line of the 88.22 acre tract and the extension thereof, to a stone monument found on the south line of the quarter section.
- 15) S 87° 36' 05" W 1397.70 feet, along the south line of the quarter section, to the **Point of Beginning**.

3.431 Acres

Situated in the State of Ohio, County of Wayne, **Township of East Union** in the **southeast quarter of Section 11** and the **southwest quarter of Section 12, T-16N, R-12W.**

Being part of the land described in a deed to **Jonathan N. Troyer and Jodi R. Troyer** recorded in official record volume 959, page 1067 of the Wayne County records.

Described as follows:

Commencing at a 1-1/2 inch diameter steel pin found marking the southwest corner of Section 12.

Thence N 00° 37' 46" W 1141.49 feet, along the west line of the quarter section, to a point.

Thence S 86° 15' 09" W 7.76 feet, into the southeast quarter of Section 11, to a point in Carr Road (County Road 94-A) on an easterly line of Eli A. Keim and Clara A. Keim as described in official record volume 947, page 633, the **Point of Beginning** for the parcel herein described – witnessed by a capped reference pin set N 86° 15' 09" E 31.09 feet.
