
Thence with the following 4 courses;

1. **N 00°22'39" W, 264.85** feet with an easterly line of Zimmerman & Amstutz, to an iron pin set with I.D. cap;
2. **N 89°28'14" E, 205.59** feet thru the Grantors land to an iron pin set with I.D. cap;
3. **S 00°22'39" E, 264.85** feet thru the Grantors land to an iron pin set with I.D. cap on the south line of the Grantor and Township Line;
4. **S 89°28'14"W, 205.59** feet with the Grantors south line and Township Line to the place of beginning and containing within said bounds **1.250** acres be the same more or less, and subject to all right of ways and easements of record.
