3. N 00° 35' 22" W, 868.32 feet along the east line of said Richard P. Sarno & Wendy J.  
Delrio to the northeast corner thereof and in T.R.448 (Bair Rd.) and also being the south  
line of Smythe as aforesaid~ witnessed by a 5/8" rebar found S 00° 35' 22" E at 31.64  
feet;
