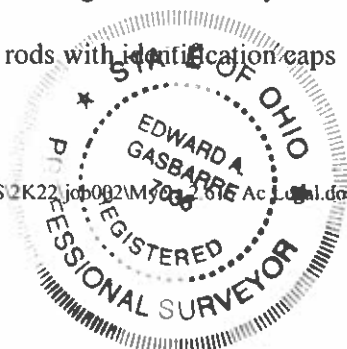

## ACCESS EASEMENT DESCRIPTION

**Commencing** at a record steel pipe marking the northwest corner of the southwest quarter of Section 27.

Thence S 03° 12' 34" W 1351.15 feet, along the west line of the quarter section, to a one inch diameter steel pipe found on the south line of Henry E. and Nettie D. Miller as described in official record volume 885, page 2616.

Thence S 86° 30' 00" E 1150.78 feet, along the south line of Miller and the extension thereof, to a point in Millersburg Road (State Route 83) on the westerly line of said Bonnie J. Myers.

Thence N 21° 39' 15" E 48.65 feet, in Millersburg Road and along the westerly line of Myers, to the **Point of Beginning** for the easement herein described - witnesses by a capped reference pin set S 68° 18' 56" E 30.00 feet.
