

BOUNDARY DESCRIPTION

1.153 Acres

Situated in the State of Ohio, County of Wayne, **Township of Franklin** in the **southeast quarter of Section 12, T-14N, R-13W.**

Being part of the land described in a deed to **Marvin L. and Fannie H. Weaver** recorded in official record volume 899, page 360 of the Wayne County records.

Described as follows:

Commencing at a marked granite stone found marking the center of Section 12.

Thence N 89° 11' 37" E 117.34 feet, along the north line of the quarter section, to the northwest corner of said Weaver - witnessed by a 1-3/4 inch diameter steel pipe found S 25° 45' 53" E 0.71 feet.

Thence S 25° 45' 53" E 1146.48 feet, along the westerly line of Weaver, to the southwesterly corner thereof and the **Point of Beginning** for the parcel herein described – witnessed by capped reference pins found N 25° 45' 53" W 10.00 feet and S 70° 37' 34" E 10.00 feet.

- 3) **S 89° 56' 48" W 310.49 feet**, along a northerly line of J & P Land Holdings, LLC as described in official record volume 966, page 549, to 1-1/4 inch diameter steel pipe found.
- 4) **N 70° 37' 34" W 325.75 feet**, along the northerly line of Joshua and Arie Miller as described in official record volume 964, page 4372, to the **Point of Beginning**.

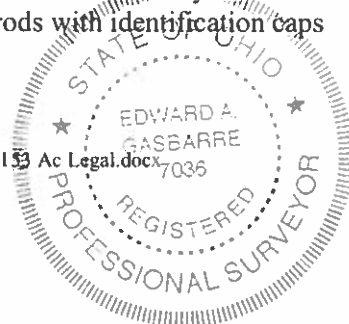

Commencing at a marked granite stone found marking the center of Section 12.

Thence N 89° 11' 37" E 117.34 feet, along the north line of the quarter section, to the northwest corner of Marvin L. and Fannie H. Weaver as described in official record volume 899, page 360 – witnessed by a 1-3/4 inch diameter steel pipe found S 25° 45' 53" E 0.71 feet.

Thence S 25° 45' 53" E 1146.48 feet, along the westerly line of Weaver, to the southwesterly corner thereof and the **Point of Beginning** for the parcel herein described – witnessed by capped reference pins found N 25° 45' 53" W 10.00 feet and S 70° 37' 34" E 10.00 feet.

- 4) **S 00° 44' 08" E 139.76 feet**, along a westerly line of J & P Land Holdings, LLC, to a 1-1/4 inch diameter steel pipe found.
- 5) **S 89° 17' 13" W 519.51 feet**, along a northerly line of J & P Land Holdings, LLC, to a point in Fredericksburg Road (County Road 501) – witnessed by a capped reference pin marked "Baker Surveying, LLC" found N 89° 17' 13" E 30.09 feet.

- 6) **N 25° 47' 49" W 27.60 feet** in Fredericksburg Road and along the easterly line of Mary Miller and Esther Miller as described in official record volume 967, page 4211, to a point – witnessed by 1-3/4 inch diameter steel reference pipe found N 89° 18' 05" E 33.57 feet.
- 7) **N 89° 18' 05" E 331.20 feet**, in part along the south line of Lot 15 of the JB Lytle Allotment No. 1 as recorded in plat volume 6, page 347, to a 1-1/2 inch diameter steel pipe found at the southeast corner thereof.
