Situated in the City of Wooster, Township of Wayne, T-16N; R-13W, Northeast Quarter of Section 26, County of Wayne, and State of Ohio:

Known as being part of the lands conveyed to The Donald and Alice Noble Foundation, LLC by Official Record Volume 672; Page 2337 of Wayne County Records. Permanent Parcel Number 74-00003.000 and further bounded and described as follows:

Commencing at a cotton gin spike found and being the southeast corner of the Northeast Quarter of Section 26;

Thence, S 89° 07' 59" W, 1099.84 feet along the quarter section line to a point on the northwesterly right of way line of Akron Road, (State Route 585, right of way varies), and the southeasterly line of Lot 9801 of the LUK Allotment No. 6 as recorded in Plat Volume 31, Page 222 of the Wayne County Records;

Thence, N 36° 00' 49" E, 40.25 feet along the northwesterly right of way line of Akron Road and the southeasterly line of said Lot 9801 to a 5/8 inch rebar with I.D. cap "Engineering Associates";


