2.) thence S 00°29'50" E, 281.79' along the easterly line of Burge Family Farms LLC as recorded in Official Record Volume 279, p. 982 to a 5/8" rebar found;

3.) thence N 88°51'37" W, 621.39' along the northerly line of said Burge Family Farms LLC to a 5/8" rebar found;

4.) thence N 41°27'10" W, 108.71' along the westerly line of said Burge Family Farms LLC to a 5/8" rebar with an orange "Laurila #7663" cap set;

7.) thence N 01°14'39" E, 47.54' to a 5/8" rebar with an orange "Laurila #7663" cap set;


8.) thence N 89°32'11" **E**, 35.97' to a 5/8" rebar with an orange "Laurila #7663" cap set;

5.) thence S 80°10'01" W, 35.31' to a 5/8" rebar with an orange "Laurila #7663" cap set;


6.) thence N 87°09'40" W, 220.08' to a 5/8" rebar with an orange "Laurila #7663" cap set;
