

BOUNDARY DESCRIPTION
3.540 Acres

Situated in the State of Ohio, County of Wayne, **Township of Plain** in the **northeast quarter of Section 2, T-19N, R-14W.**

Being the sum of a 2.44 acre parcel and a 1.096 acre parcel described in a deed to Jacqueline R. Stroud recorded in official record volume 965, page 1581 of the Wayne County records.

Described as follows:

Commencing at stone monument found on the line between Plain Township and Chester Township marking the northeast corner of Section 2.

Thence S 2° 55' 00" W 649.60 feet, along the east line of the quarter section, to an iron corner found in Smyser Road (Township Road 35) at the northeast corner of Nicholas O. Coppola and Kaylee R. Becker as described in official record volume 885, page 5408.

Thence N 81° 30' 00" W 200.00 feet, along the north line of Coppola and Becker, to the northwest corner thereof and the **Point of Beginning** for the parcel herein described – witnessed by an iron monument found N 65° 40' 06" W 0.62 feet.

Thence with the following SEVEN courses:

- 1) **S 3° 00' 00" W 233.39 feet**, along the west line of Coppola and Becker and the extension thereof, to an iron corner found on the north line of Paul E. Lyons as described in official record volume 955, page 2527.
- 2) **N 85° 00' 00" W 199.40 feet**, along the north line of Lyons and the extension thereof, to the northwest corner of Diana L. and Lon D. Frazier as described in official record volume 941, page 1969.
- 3) **S 3° 05' 00" W 420.25 feet**, along the west line of Frazier, to an iron corner set in Silver Road (County Road 4) at the southeast corner of the previously mentioned 2.44 acre parcel – witnessed by an iron reference monument set N 3° 05' 00" E 35.00 feet.
- 4) **N 85° 00' 00" W 158.50 feet**, in Silver Road and along the south line of the 2.44 acre parcel, to an iron corner set - witnessed by an iron reference monument set N 3° 05' 00" E 35.00 feet.
- 5) **N 3° 05' 00" E 677.75 feet**, along the west line of the 2.44 acre parcel, to an iron monument set.

- 6) S 81° 01' 00" E 259.21 feet, along the north line of the 2.44 acre parcel and the extension thereof, to an iron monument found at the southwest corner of Brock Taylor Yoder as described in official record volume 931, page 1093.
- 7) S 81° 30' 00" E 99.97 feet, along the south line of Yoder, to the **Point of Beginning**.

This parcel contains 3.540 acres.
