Bonewitz as recorded in O.R.498, Page 1396, witnessed by a Purdy pin found S 88° 35' 47" W at 30.01 feet; Thence S 88° 35' 47" W, 305.85 feet with the south line of Robert E. Bonewitz to a capped pin set and being the place of beginning of the parcel herein described;
