ORDINANCE NO. 2025-01

AN ORDINANCE VACATING AN UNNAMED ALLEY RUNNING IN
A EAST TO WEST DIRECTION IN THE CITY OF WOOSTER FROM
THE EASTERNMOST BORDER OF WAYNE COUNTY PARCEL 64-
01930.000 TO THE SOUTHEASTERN CORNER OF WAYNE COUNTY
PARCEL 64-02038.000

WHEREAS, the owner of Lot Nos. 3627, 3528, 3529, 3523, NWpt OL 40, NWpt OL 41, and Parcel
Nos. 64-1927.000 and 64-01930.000 (Lot B) have petitioned for the vacation of a one thousand (1,000) foot
public alley running from the easternmost border of Wayne County Parcel 64-01930.000 to the southeastern
corner of Wayne County Parcel 64-02038.000, as shown by the attached petition to vacate and map thereof;
and

WHEREAS, the petitioner is the owner of lots adjacent and contiguous to the subject alley; and

WHEREAS, notice of said petition was not necessary pursuant to Ohio Revised Code Section 723.06;
and

WHEREAS, this City Council is satisfied that there is good cause for vacating said alley and that it
will not be detrimental to the general interest of the public.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WOOSTER,
OHIO:

SECTION 1. After holding a public hearing on this matter, the one thousand (1,000) foot public alley
running from the easternmost border of Wayne County Parcel 64-01930.000 to the southeastern corner of
Wayne County Parcel 64-02038.000, as shown on the map attached, is vacated.

SECTION 2. The Clerk of Council is directed to certify a copy of this Ordinance, together with a map
of the vacated alley, and record the same in the Office of the Recorder of Wayne County, Ohio.

SECTION 3. This Council finds and declares that all formal actions concerning and relating to the
adoption of this Ordinance occurred in an open meeting of this Council or its committees, in compliance with
the law.

SECTION 4. This Ordinance shall take effect and be in force from and after the earliest period
allowed by law.

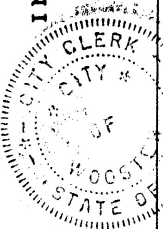

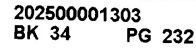
