RESOLUTION TO PETITION THE BOARD OF COUNTY COMMISSIONERS, WAYNE COUNTY, OHIO

TO VACATE THE SOUTHERN PORTION OF FORCES ALLEY IN THE UNINCORPORATED VILLAGE OF MORELAND,

FRANKLIN TOWNSHIP, WAYNE COUNTY, OHIO

WHEREAS, pursuant to R.C. 5553.045(B), a board of township trustees may petition the board of county commissioners to vacate a township road or portion of a township road by adopting a resolution requesting the vacation of the road or portion or road, which includes a description of the general route and termini of the road or portion of the road requested to be vacated; and

WHEREAS, as used in R.C. 5553.045, "road" means a road, or portion of a road, which is not used to calculate distributions of the auto registration distribution fund under division (E) of section 4501.04 of the Revised Code and, thus, is not a road or portion of a road certified by the board of township trustees to the director of transportation in accordance with that division as mileage in the township used by and maintained for the public.

WHEREAS, the southern portion of Forces Alley a township road in the unincorporated Village of Moreland, Franklin Township, Wayne County, Ohio is requested to be vacated, described further in Exhibit 2 and depicted in Exhibit 1 attached hereto and incorporated herein, is not used to calculate distribution of the auto registration distribution fund under R.C. 4501.04(E), and, thus, is not a road certified by the Franklin Township Board of Trustees to the director of transportation as mileage in Franklin Township used by and maintained for the public; and

WHEREAS, the Franklin Township Board of Trustees desires to petition the Board of Commissioners, Wayne County, Ohio to vacate the southern portion of Forces Alley which is further described and depicted in Exhibit 2 and Exhibit 1.

NOW, THEREFORE, BE IT RESOLVED, that the Franklin Township Board of Trustees hereby requests the vacation of the southern portion of Forces Alley which is described and depicted in Exhibit 2 and Exhibit 1; and

BE IT FURTHER RESOLVED, that the Franklin Township Board of Trustees hereby directs the Franklin Township Fiscal Officer to file a copy of this Resolution, as a petition for vacation, with the Board of County Commissioners, Wayne County, Ohio and to certify another copy to the Wayne County Engineer.

IT IS FURTHER RESOLVED, that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board of Township Trustees and that all deliberations of such Board were in meetings open to the public, in compliance with Ohio law, including R.C. 121.22.

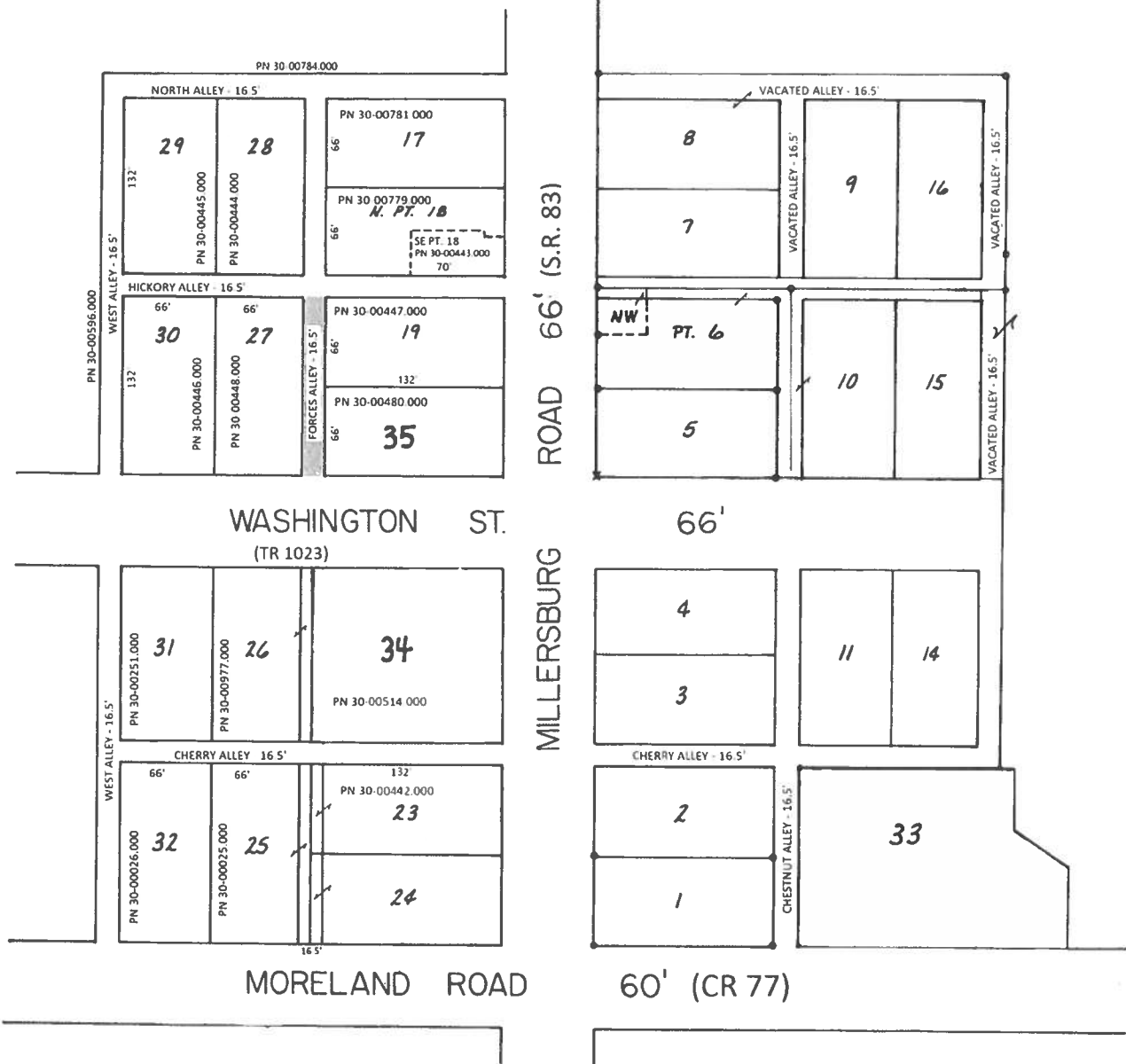
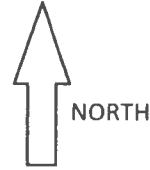

Vacation of the Southern Portion of Forces Alley, 16.5 feet wide, in the Unincorporated Village of Moreland. Situated in the S.W. Quarter of Section 4, Twp. 14 N., R. 13 W. in Franklin Township, Wayne County, Ohio and being a strip of land 16.5 feet by 132 feet between the Northern R/W Line of Washington St. (66')(TR 1023) to the Southern R/W line of Hickory Alley (16.5') as recorded in Plat Book Volume 1, Page 29. Attached Exhibit 1 shows proposed vacated alley marked in gray highlight.
