ORDINANCE D-25

Ordinance No. _____ Passed _____

An Ordinance vacating an alley which runs east and west parallel to Hostetler Rd. and between 1.428 acre and 1.362 acre parcels and City Lots Number 3272 and 3742, Wayne County Parcels 59-02878.000, 59-02877.000, 59-02341.000 and 59-02128.000 in the City of Orrville, Ohio.

WHEREAS, the City of Orrville ("Petitioner") has requested to vacate an alley running east and west, parallel to Hostetler Rd., between Wayne County Parcels 59-02878.000, 59-02877.000, 59-02341.000 and 59-02128.000, in the City of Orrville, Ohio; and

WHEREAS, all adjoining lots are owned by the City of Orrville, Ohio; and

WHEREAS, this request has been considered and recommended by the Orrville Planning Commission at its meeting on June 19, 2025; and

WHEREAS, the vacation of this alley will not adversely impact the public.

BE IT ORDAINED by the Council of the City of Orrville, Ohio:

Section 1: This Council hereby finds that the hereinafter described alley, which is also shown on the map attached hereto and incorporated herein as Exhibit A, should be vacated, that there is good cause for the vacation of said alley, and that vacation of said alley is not detrimental to the general interest.

Section 2: The Council hereby finds that there are no other abutting property owners other than Petitioner and because Petitioner has consented to the vacation of the alley, notice of Council's interest to vacate is not required to be given pursuant to ORC §723.06.

Section 3: A description of the abutting parcels is attached hereto as Exhibit B.

Section 4: The Clerk of this Council is respectfully directed to cause a certified copy of this Ordinance to be filed in the office of the Wayne County Recorder and properly indexed therein and to further cause a certified copy to be filed in the office of the Wayne County Auditor.

Section 5: That this Ordinance shall take effect and be in full force from and after the earliest period allowed by law.

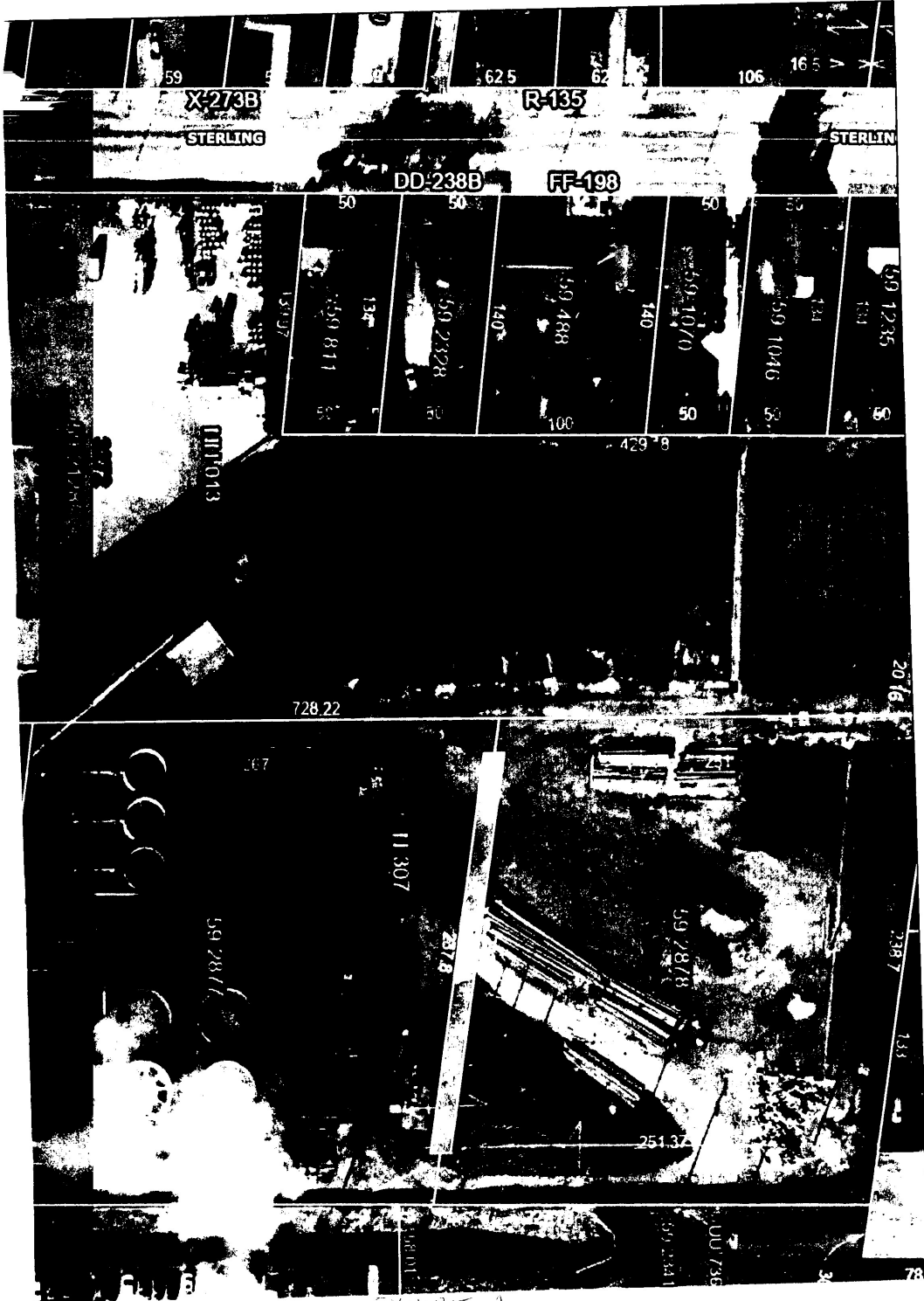

Parcel 1:

Situated in the City of Orrville, County of Wayne and State of Ohio:

Beginning at an iron pin at the intersection of the West property line of Vine Street with the North property line of Mineral Spring Street,

Thence North 3° and 12" West on the West line of Vine Street 515.76 feet to an iron pin for the place of beginning;

Thence continuing North 3° and 12" West on said West line of Vine Street 267 feet to an iron pipe at the South line of an alley;

Thence 85° and 47" West and parallel with Mineral Spring Street 234.9 feet to an iron pin at the intersection of the south line of said alley with the West line of Perry Street;
