## ORDINANCE M-21

An Ordinance vacating, pursuant to Ohio Revised Code Section 723.04, a portion of Union Street, in the City of Orrville, Ohio, between Main Street and Vine Street, between Parcels No. 59-00158.000 and 59-00158.001 to the south and Parcel No. 59-00157.000 and 59-00731.000 to the north and retaining a permanent easement pursuant to Ohio Revised Code Section 723.041.

WHEREAS, Campbell Oil Company, Monkey Weasel Ltd., and Flo Properties, LLC, filed a Petition to vacate a certain portion of Union Street, located between properties it currently owns in the City of Orrville, Ohio, due to safety concerns in its utilization of its facilities, crossing the street with vehicles, equipment, and machinery.

WHEREAS, said Petition was duly considered by the Planning Commission with a recommendation for approval by same.

WHEREAS, said Petition was further considered by the Planning Committee of Council with a recommendation that the Application be submitted to Council in the form of legislation.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Orrville, Ohio:

Section 1: This Council hereby finds that the hereinafter described portion of Union Street, Orrville, Ohio, between Main Street and Vine Street between Parcels No. 59-00158.000 and 59-00158.001 to the south and Parcels No. 59-00157.000 and 59-00731.000 to the north, should be vacated, that there is good cause for the vacation of said portion of Union Street, and that vacation of said portion of Union Street shall not be detrimental to the general interest.

Section 2: That this Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
