

## Description 1.500 Acres

Situated in the Township of East Union, T- 16 N, R-12 W, Southeast Quarter of Section 36, County of Wayne, and State of Ohio:

Commencing at a stone found marking the northeast corner of the southeast quarter of section 36, thence S 00 degrees 41'35" E a distance of 1043.81 feet along the section line and the Sugar Creek Township line to a point in Berg Road (T.R. 208) witnessed by an iron pin found S 00 degrees 41'35" E a distance of 20.00 feet, thence S 83 degrees 48'21" W a distance of 73.92 feet along said road and the north line of Levi J. Gingerich and Milan J. and Gertrude E. Weaver (O.R. Vol. 889 Page 4975) to a point witnessed by an iron pin set N 82 degrees 39'12" W a distance of 1617.00 feet, thence N 82 degrees 39'12" W a distance of 528.54 feet along said road and the north line of said of Levi J. - 2. N 05 degrees07'24" E a distance of 235.01 feet through the lands of said Joe B. and Mary J. Yoder to an iron pin set passing through an iron pin set at a distance of 14.13 feet;
- 3. S 86 degrees10'54" E a distance of 268.67 feet through the lands of said Joe B. and Mary J. Yoder to an iron pin set;
- **4.** S 05 degrees07'24" W a distance of 251.56 feet through the lands of said Joe B. and Mary J. Yoder to the TRUE PLACE OF BEGINNING.
