- 3) S 00° 26' 22" E 586.92 feet, along a westerly line of Kauffman, to a capped pin set on the south line of the quarter section.
- 4) S 89° 58' 50" E 1286.02 feet, along the south line of the quarter section, to a pointed granite stone found marking the southeast corner thereof.
- 5) S 00° 21' 42" E 1217.86 feet, into the northwest quarter of Section 25 and along the east line of the quarter section, to a northeasterly corner of Kevin T. Power and Susan G. Power, Co-Trustees as described in official record volume 904, page 4238 witnessed by a 1-1/4 inch diameter steel pipe found S 89° 16' 27" W 2.85 feet.
- 6) S 89° 16' 27" W 739.94 feet, along a northerly line of Power, to a 5/8 inch diameter steel pin found at the southeast corner of John R. and Gloria E. Bernadine as described in official record volume 208, page 641.
- 7) N 00° 23' 03" W 817.11 feet, along the east line of Bernadine, to a one inch diameter steel pipe found.

- 8) S 89° 15' 58" W 548.90 feet, along the north line of Bernadine and the extension thereof, to a one inch diameter crimped steel pipe found.
- 9) S 00° 11' 52" E 110.48 feet, along the west line of Bernadine, to a 5/8 inch diameter steel pin found at a northeasterly corner of the previously mentioned Power.
- 10) N 89° 58' 50" W 1334.38 feet, along the north line of Power, to a point on the west line of the quarter section and in Fredericksburg Road witnessed by a capped reference pin set S 89° 58' 40" E 25.00 feet.
- 11) N 00° 00' 30" W 528.00 feet, along the west line of the quarter section and in Fredericksburg Road, to the Point of Beginning.

This parcel contains 60.141 acres; of which 17.991 acres lie in the southwest quarter of Section 24 and 42.150 acres lie in the northwest quarter of Section 25.
