A RESOLUTION VACATING TWO UNNAMED ALLEYS THAT THE VILLAGE OF DALTON HAS DETERMINED WILL NOT BE DETRIMENTAL TO THE GENERAL INTEREST OF THE VILLAGE AND DECLARING AN EMERGENCY.

WHEREAS, two unnamed alleys, running East/West between Matz Court and Locust Street and running North/South between Henry Street and Wertz Avenue located in the Village of Dalton ("Village");

WHEREAS, the Village believes there is good cause for the vacation of these two alleys;

WHEREAS, said vacation shall not be detrimental to the general interest.

NOW THEREFORE, IT IS HEREBY RESOLVED by the Council of the Village of Dalton, County of Wayne and State of Ohio:

Section 1. This Council hereby finds that these two unnamed alleys, running East/West between Matz Court and Locust Street and running North/South between Henry Street and Wertz Avenue which are shown on the map attached hereto and incorporated herein as Exhibit A, should be vacated, that there is good cause for the vacation of these alleys, and that said vacation shall not be detrimental to the general interest of the Village.


