Situated in the State of Ohio, County of Wayne, Original Township of Chippewa, Northeast Quarter of Section 2, Township 18, Range 11, Congress Lands North of the Seven Ranges, and being all of Parcel A,B, and V as conveyed to JGB and Associates, LTD. by Official Record 909, Page 1623 of said county records and bounded and described as follows:

BEGINNING at a 1 inch rebar found at the intersection of centerlines of Eastern Road (County Road 150, width varies) and Hametown Road (County Road 169, 60 feet wide), on the south line of Summit County and the north line of Wayne County, at the northwest corner of Section 1 and the northeast corner of said Section 2:

- 1) Thence on the centerline of said Flametown Road, the west line of said Section 1, and the east line of said Section 2, South 0 degrees 41 minutes 13 seconds East, a distance of 120.00 feet, to the northeast corner of a parcel conveyed to Paul C. Racin as recorded in Official Record 652, Page 170:
- 2) Thence on the north line of said Racin parcel, South 89 degrees 28 minutes 21 seconds West, a distance of 181.44 feet to a 1 inch pipe found at the northwest corner of said Racin parcel, passing over a rebar set on the west right of way line of said Hametown Road at 30.00 feet;
- 3) Thence on the west line of said Racin parcel, South 0 degrees 40 minutes 24 seconds East, a distance of 41.77 feet, to a rebar set at the northeast corner of a parcel conveyed to Summit Properties Management, Inc. as recorded in Official Record 997, Page 160;
- 4) Thence on the north line of said Summit Properties Management, Inc. parcel, South 89 degrees 26 minutes 18 seconds West, a distance of 388.92 feet, to a rebar set at the southeast corner of a parcel conveyed to BML Properties, LLC, as recorded in Official Record 910, Page 5848, passing over a 1 1/2 inch pipe found at 71.53 feet;
- 5) Thence on the east line of said BML Properties, LLC, North 0 degrees 50 minutes 18 seconds West, a distance of 162.20 feet, to the centerline of said Eastern Road, the north line of said Section 2, and said County line, passing over a rebar set on the south right of way line of said Eastern Road at 132.20 feet;

WHEREAS, Division (D) of Section 709.023 of the Ohio Revised Code obligates this Board to grant the proposed annexation if said municipal corporation and township(s) give the consent referenced above; and

WHEREAS, no objections were received from the City of Norton or Chippewa Township during the twenty-five-day objection period.

CITY OF NORTON ORDINANCE NO. 2-2021

AN ORDINANCE ACCEPTING THE PETITION FOR ANNEXATION OF LAND BY THE PROPERTY OWNERS IN THE JGB ANNEXATION AREA, LOCATED IN CHIPPEWA TOWNSHIP, WAYNE COUNTY, TO THE CITY OF NORTON; AND DECLARING AN EMERGENCY.

WHEREAS, on October 9, 2020, pursuant to Ohio Revised Code Section 709.023, the property owners seeking the annexation of 1.9473 acres of real property in Chippewa Township, Wayne County, Ohio (the "Property"), contiguous to the City of Norton (the "City"), filed a Petition for Annexation (the "Petition") of their property to the City with the Board of County Commissioners of Wayne County, Ohio, a copy of which is attached hereto as Exhibit "A", notice of which was duly served upon the City as prescribed by law; and,

WHEREAS, pursuant to Ohio Revised Code Section 709.023(C), the City adopted Resolution No. 086-2020 on October 13, 2020, which Resolution indicates the type and scope of services the City will provide to the territory upon annexation to the City; and,

WHEREAS, on November 9, 2020 a certified copy of Resolution No. 086-2020 was received by the office of the Clerk of the Board of Wayne County Commissioners (the "Board of Commissioners"); and,

WHEREAS, the Petition came on for public hearing before the Board of Commissioners on November 4, 2020; and,

WHEREAS, pursuant to an action of the Board of Commissioners after that hearing, the Clerk of the Board of Commissioners entered on the journal of the Board of Commissioners an order approving the annexation according to law, certified the transcript for the proceeding in connection with the annexation and filed it with the Clerk of Council of the City on November 9th, 2020; and,

WHEREAS, pursuant to Ohio Revised Code Section 709.04, the Clerk of Council is required to place before this Council the annexation documents at the next regular meeting of this Council following the expiration of 60 days from the receipt by her; and,

WHEREAS, this Council is required to accept or reject the Petition within 120 days thereafter.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Norton, Summit and Wayne Counties, State of Ohio:

- Section 1. The proposed annexation of 1.9473 acres from Chippewa Township, Wayne County, Ohio to the City, a petition for which was filed with the Board of Commissioners on October 9, 2020, and approved by the Board of Commissioners on November 4, 2020, be and the same is hereby accepted. The Resolution of the Board of Commissioner's approval and the Petition, which graphically depicts and describes the territory that is the subject of the annexation, are attached hereto as Exhibit "A" and incorporated herein. The certified transcript of the proceedings of the Board of Commissioners has been on file with the Clerk of this Council for 60 days.
- Section 2. The Clerk of Council is hereby authorized and directed to make 4 copies of this Ordinance, to each of which shall be attached a copy of the map accompanying the Petition for Annexation, a copy of the transcript of the proceedings of the Board of County Commissioners relating thereto and a certificate as to the correctness thereof. The Clerk of Council shall then deliver one copy to the Wayne County Auditor, one copy to the Wayne County Recorder, one copy to the Summit County Fiscal Officer and one copy to the Secretary of State and shall file notice of this annexation with the Board of Elections of Wayne County and the Board of Elections of Summit County within 30 days after this Ordinance becomes effective, and further the Clerk of Council shall do all other things with respect to the action taken by the Ordinance as may be required by law.
- Section 3. All formal actions of this Council related to this Ordinance and all deliberations of the Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with legal requirements, including section 121.22 of the Ohio Revised Code.
- Section 4. This Ordinance is an emergency measure necessary for the preservation of the public peace, health, safety, convenience, and welfare of the City of Norton and the inhabitants thereof, and permits the City to timely complete the annexation of the Property in furtherance of the authorized purposes of the City, and provided it receives the approval of two-thirds of the members of Council, shall be in full force and effect from and after its passage and approval by the Mayor, or otherwise take effect and be in full force from and after the earliest period allowed by law.
